2011 marks the fourth consecutive year that the students of Old Richmond Elementary School, led and inspired by Andrea Bostic, raised funds in support of Riverwood. The 5th graders alone raised \$2,200 for Riverwood and continue their sponsorship of Gator! The entire 5th grade made a trip to the farm where they hiked through the trails, had the privilege of watching several Riverwood students ride, and enjoyed a pizza party generously donated by Hilary Kosloske.



In a truly heartwarming gesture, the students wrote thank you letters to Riverwood for their experience. Big Tony was an instant hit, according to everyone's "favorite part" about the visit ("I especially loved Tony," "I got to pet Tony," "Tony was my favorite horse, he is HUGE!"). One student's remarkable comments: "It was amazing to me to think some of these people had to sit in a wheelchair for most of their time. And riding the horses gave them the opportunity to get out." Another student captured much of our spirit, and the lessons we teach every day saying, "I think it's an amazing thing what you do for kids with disabilities. You don't care what they look like or how they are different which is a really good thing."

As a closing comment to one letter, a student wrote, "I will never forget it!" Believe us when we say Riverwood will never forget the students, teachers, and staff of Old Richmond Elementary!

Spreading the News

We are always excited about opportunities to help educate the community about the benefits of equine assisted activities. This year, Riverwood and Hughes Equine Energy have had the unique opportunity to partner with Northwest AHEC. The Northwest Area Health Education Center is an educational outreach and training program designed to enhance the health of the public through diverse community/academic partnerships.

We have had the chance to offer workshops about our Equine Assisted Psychotherapy and Learning (EAP/L) program to educate the medical and professional community. "The Power of Working with Horses" is a 3 hour interactive workshop that gives people the chance to see how equine assisted psychotherapy and learning can be powerful therapeutic modalities. The workshops also offer 3 CEU credits for professionals.

We have partnered with AHEC for four workshops so far in 2011, and we are already planning three more over the next year. Our partnership is one we hope to continue for many years.

Dear Friends,


